Update for Killdeer

WE now have 2 people supported that have tested positive for COVID-19 and are awaiting the test results from the other two supported people.

We have had 1 staff test positive as well with several others still awaiting results still. We have the following homes in an alert due to possible exposure ( staff with school kids, staff symptomatic and awaiting results)

Simcoe, Old Scugog (child symptomatic from school – lives with grandmother (who works at Simcoe) and Aunt (who works at Scugog)

Holt, - person supported – symptomatic and tested on Tuesday – awaiting results

425 Adelaide – partner of staff from Killdeer – both are symptomatic and we have put them both off for 14 days as they are refusing to be tested or do screening. House is under enhanced precautions and more intensive and frequent cleaning and monitoring all for any symptoms until Monday.

39 Wellington office – symptomatic staff – off pending results of test. Office fogged today again
